Active Minds empowers students to speak openly about mental health in order to educate others and encourage help seeking. We are changing the culture on campuses and in the community by providing information, leadership opportunities and advocacy training to the next generation.

Chapter Development and Support: Active Minds is dedicated to promoting the student voice in mental health. In 2016-2017, the organization supported chapters on 448 college and high school campuses in 47 U.S. states and 4 countries. These 448 chapters trained 15,152 volunteers, representing a growth of 23% in just one year. These volunteers reached 270,556 young adults through an astounding 2,639 events with vital information about suicide prevention, promoting mental health, symptoms of mental illness, and available resources for seeking help.

Active Minds Speakers Bureau: Research shows that the best way to break stigma around mental health is through personal contact. As a result, Active Minds has recruited and trained 16 professional speakers to tell their stories around mental health in an engaging, educational, and powerful manner. Members of the speakers bureau travel the country through the year giving keynote presentations at high schools and colleges; to parents and administrators; and at conferences and national events. In 2016-2017, the Speakers Bureau held 102 speaking engagements in 27 states, reaching 42,454 young people.

National Conference: The Active Minds National Conference is the leading conference in college mental health. The 2016 Conference in Sacramento, CA brought together 372 student, staff and professional attendees from 30 states representing 69 colleges and universities, 2 high schools, and 30 organizations. To supplement the Active Minds- supplied materials and resources, the following organizations exhibited at the 2016 conference: National Institute of Mental Health, Veterans Crisis Line, Each Mind Matters, and Text, Talk, Act.
