1 Briefly describe the organization's mission: Active Minds empowers students to speak openly about mental health in order to educate others and encourage help seeking. We are changing the culture on campuses and in the community by providing information, leadership opportunities and advocacy training to the next generation.

4a (Code:) (Expenses \$ 538,836 including grants of \$) (Revenue \$ 1,488) Chapter Development and Support: Active Minds is dedicated to promoting the student voice in mental health. In 2017-2018, the organization supported chapters on 479 college and high school campuses in 48 U.S. states and 4 countries. These 479 chapters trained more than 17,000 volunteers, who reached 407,082 young adults with vital information about suicide prevention, promoting mental health, symptoms of mental illness, and available resources for seeking help through unique Active Minds programming and training.

4b (Code:) (Expenses \$ 297,888 including grants of \$) (Revenue \$ 289,176) Active Minds Speakers Bureau: Research shows that the best way to break stigma around mental health is through personal contact. As a result, Active Minds has recruited and trained 14 professional speakers to tell their stories around mental health in an engaging, educational, and powerful manner. Members of the speakers bureau travel the country through the year giving keynote presentations at high schools and colleges; to parents and administrators; and at conferences and national events. In 2017-2018, the Speakers Bureau held 128 speaking engagements in 28 states.

4c (Code:) (Expenses \$ 274,985 including grants of \$) (Revenue \$ 55,114) Public Education and Awareness Campaigns: Active Minds has created Awareness Day programming for our chapters and supporters such as Suicide Prevention Month, National Day without Stigma, Stress Less Week, and PostSecret U. During these programs, large numbers of students and community members are introduced to mental health topics that are very relevant and often misunderstood, in an approachable way. By educating through innovative and relevant means including a comprehensive website at www.activeminds.org, and an interactive presence on Facebook, Twitter, and Instagram, Active Minds aims to raise public consciousness and change the way mental health issues are understood and publicly approached. In 2017-2018, 1,388 campuses and communities ran Active Minds' Public Education and Awareness Campaigns, with an estimated in-person and online reach of 437,702 people.
